FAMILIES IN TRANSITION FIT

Families change after separation and divorce. Many critical issues need to be addressed from paternity, custody, and parenting arrangements - to a range of pressing needs of children. For parents and children, it is a challenging time.

FAMILIES IN TRANSITION, FIT, offers a two session workshop focusing on the needs of children when their parents separate or divorce. FIT is appropriate for both married and unmarried parents. The 5-hour workshop is divided into two 2 ½ hour sessions, a week apart and is led by a male/female team of parent education specialists.

In the workshop you will learn about:

- How children react to separation and divorce at different ages
- What children need to know and how to talk with them about separation/ divorce
- Parenting in two households
- Problem-solving as co-parents
- Pitfalls to avoid
- How to help your children survive separation/divorce with strength and resilience

Who Attends?

In divorce cases affecting minor children, Probate and Family Court requires *both* parents to attend. After completing the 2-session program, participants receive certificates and the Court is notified. Other parents may be ordered by the Court - or may voluntarily choose - to attend.

How to Register

Each parent is required to attend separate

sessions. All participants must pre-register. No walk-ins are permitted.
